ON 10/07/2005 AT APPROXIMATELY 1945 HOURS I RESPONDED TO 12628 E TAMIAMI TRL (WINN DIXIE) IN REFERENCE TO A PETIT THEFT, SUSPECT IN CUSTODY.

UPON ARRIVAL I MADE CONTACT WITH THE ASSISTANT MANAGER MS HYROZYK. MS HYROZYK STATED SHE WAS LOCATED AT THE FRONT OF THE STORE WHEN SHE NOTICED A HISPANIC MALE LEAVING THE STORE. AS THE HISPANIC MALE PASSED THROUGH THE CHECK POINT THE ALARM WENT OFF. MS HYROZYK CONFRONTED THE HISPANIC MALE OUTSIDE THE STORE AND DISCOVERED HE WAS CONCEALING TWO PACKAGES OF FISH IN THE WAIST BAND OF HIS SHORTS. MS HYROCYK ESCORTED THE HISPANIC MALE BACK INTO THE STORE AND TO THE FRONT DESK. ONCE AT HE FRONT DESK THE HISPANIC MALE ATTEMPTED TO RUN AWAY. MS HYROZYK RAN AFTER THE SUBJECT AND CAUGHT HIM OUTSIDE THE STORE. THE SHERIFFS OFFICE WAS CALLED AT THIS TIME. THE SUSPECT, EDUARDO CERVANTES, DETAINED BY WINN DIXIE EMPLOYEES UNTIL DEPUTIES ARRIVED.

MS HYROZYK BEING A REPRESENTATIVE OF THE WINN DIXIE COMPLETED A SWORN STATEMENT AND WISHED TO PRESS CHARGES FOR PETIT THEFT.

A PROPERTY RECEIPT WAS COMPLETED AND THE PACKAGES OF FISH WERE RETURNED TO WINN DIXIE. TOTAL VALUE OF THE FISH WAS \$9.48.

MR CERVANTES WAS PLACED INTO HANDCUFFS (DOUBLE LOCKED) AND TRANSPORTED TO NAPLES JAIL CENTER.
